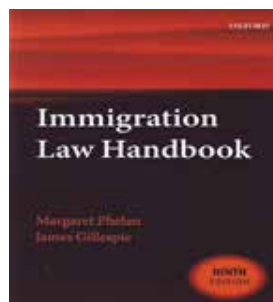
physical book just cannot provide. And as the late, great Douglas Adams once said “Lovers of print are simply confusing the plate for the food”.
