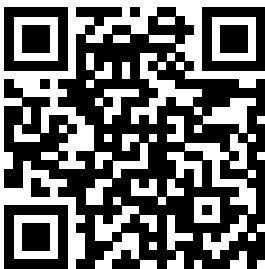
May/June 2015
