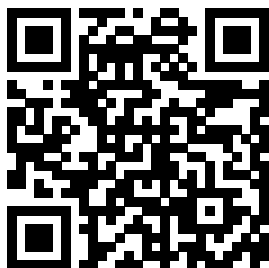

Pictures this month include the ALLA conference in Darwin which Alden and Graham attended along with a picture from the CALL conference in Halifax where John Eaton was honoured.

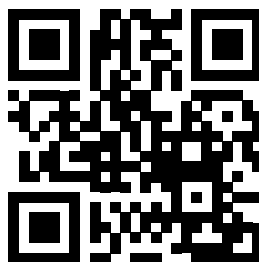
As this issue of the Book News is being prepared, the team is looking forward to the annual BIALL conference in Birmingham.
