The first edition of this book quickly established itself as the leading reference work on the rapidly developing law of privacy in England and Wales, and the specialist team of barristers from Five Raymond Buildings (the media, entertainment and human rights chambers) and expert academic foreign law contributors have now prepared a timely new edition. Many of the contributors have appeared or advised in the leading cases which are shaping the law of privacy.

The book considers how the law protects the publication of personal information without undermining the fundamental principle of freedom of expression. Since the first edition was published the law of privacy has developed considerably. As predicted by the authors, a separate and distinct cause of action, known as “misuse of personal information” has been created, though its precise remit is still being defined by the courts. Alongside this new tort or equitable remedy, traditional causes of action (most notably breach of confidence) remain available to provide remedies for invasions of privacy. <p>The common law continues to be influenced by the competing rights under Articles 8 and 10 of the European Convention on Human Rights and its concurrent Strasbourg jurisprudence and, to a lesser extent, by application of the principles established in the Data Protection Act 1998. The case law is developing on a case by case basis, drawing on comparative legal and academic sources where appropriate. Against this background the debate as to whether Parliament should enact a general law of privacy rumbles on. Although intended as a practitioners’ guide to the law,

this major work includes a consideration of comparative and international jurisprudence, as well as leading academic writings on the subject, in order to elaborate the principles upon which privacy rights are based. These may helpfully guide the development of English law in the years ahead. The structure moves from the historical and contextual, through the academic and comparative, to the practical and developing law. At the heart of the book is an explanation of existing causes of action which may be used to protect personal privacy and practical advice on defences and remedies that may be available. It is recognized that recent legislation, most notably the Data Protection Act 1998 and the Human Rights Act 1998, has had a significant impact on the law in this area and full consideration is given to their application. 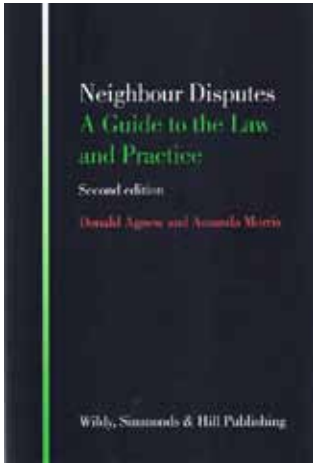

The statutory provisions on drink-driving are set out in just fifteen sections of the Road Traffic Act 1988, and two from the Road Traffic Offenders Act 1988, but there have been over 700 appeals to the Divisional Court on points of law since the Acts came into force. The result is a body of law which is technical and complex, covering a wide array of matters.

*The Drink-Drive Offences* provides a practical, comprehensive, accessible and up-to-date account of this broad and intriguing area of law. It traces the procedure from preliminary testing to penalties, taking the legislative provisions in sequence and explaining the effects of the case law. The routines for preliminary testing, and for requiring and analysing specimens of breath, blood or urine, are examined. This includes the recurring question of the reliability of the breath analysis instrument and the circumstances in which a blood or urine specimen may be required instead of a breath specimen. The constituents of the offences are explained, in chapters on the excess alcohol offences, the offences of being in charge, the offences of being unfit to drive, and causing death by careless driving when under the influence of drink or drugs. The statutory assumption that the level of alcohol at the time of the offence was no less than in the specimen receives special attention, along with the “hip flask” defence, where the motorist asserts that it was alcohol consumed after driving which accounts for being over the limit. A chapter is devoted to the offences of failing to co-operate with preliminary tests and failing to provide specimens, with full consideration of what constitutes a “reasonable excuse” for these purposes. Finally, the penalties are set out, including special reasons for not disqualifying.

Artists have to memorise in court the colours, shades, clothing, facial mannerisms and physical idiosyncracies then go out and draw a likeness from memory . . . against the clock.

Priscilla Coleman was born in Chilton, near Waco Texas and went to high school in Chilton and Huntsville before studying fine art and graphics at Sam Houston State University, Texas. Inspired by her mother Henrietta, a talented fashion illustrator and portrait painter, Priscilla is driven by a love of drawing people.
